

RESOLUTION NO. 19-14

**A RESOLUTION INCREASING SOLID WASTE COLLECTION FEES PROVIDED BY
SANITARY DISPOSAL, INC. FOR THE CITY OF IRRIGON, OR**

WHEREAS, the City of Irrigon provides a variety of services to the public; and

WHEREAS, it is common for cities to charge fees for some services to help recover the costs of providing those services; and

WHEREAS, Solid Waste Rates have not been adjusted since they went into effect in October 2016; and

WHEREAS, the City Council has established a process and procedure in which any rate change or increase will be implemented along with the calendar year in working with property landlords, tenants, and other rate structures; and

WHEREAS, the Irrigon City Council has a master fee schedule to assist the City staff and public in quickly locating the appropriate fee(s) for service in which these rate increases will become part of;

NOW, THEREFORE BE IT RESOLVED:

SECTION 1. The attached Exhibit A and Exhibit B are hereby adopted.

SECTION 2. The fees established by this resolution take precedence over any Solid Waste charges or fees which were previously adopted by any ordinance, resolution or administrative policy.

SECTION 3. The City will hold the current customer rates will be added to the Master Fee Schedule with an effective date of the customer increase on January 1, 2020 but will begin paying Sanitary Disposal the new increased rate as noted in Exhibit B effective October 1.


SECTION 4. The City Manager and staff shall review the fees periodically and shall modify the fees based on the cost of providing the services with the approval of the City Council.

SECTION 5. This resolution shall be effective immediately.



- Container placement must be easily accessible to truck and collector.
- Cart placement must be at curb or roadside.

MANUALLY EMPTIED CONTAINERS

SOLID WASTE RATE SCHEDULE:

- Containers at curb or roadside
 - Extra charges per pickup for solid, not on a regular basis (on route) \$3.00 per 32 gallon container
 - Containers are priced at level full with lid closed and extra charges will be made for “over-the-top-bulk” \$2.10 minimum
- Large bulk items set by city when charged by wholesaler
- Minimum special pickup charges to be arranged between city and collector.

REGULATIONS:

1. Regulation container (manually emptied)
 - a. Size-32 gallon maximum not to exceed 50 pounds in weight when filled and 18 pounds when empty.
 - b. Containers must have lids and handles.
 - c. Containers must be kept clean and in good condition. Plastic liners are recommended.
2. Container placement must be at curb or roadside.
3. All garbage must be drained of excess liquids and wrapped.
4. Ashes will be taken **ONLY** if placed a in plastic bag and tied. (FIRE HAZARD TO EQUIPMENT AND TRANSFER STATION.)
5. Any solid waste around the container will be taken and an extra charge made unless the collector is otherwise notified by the customer.
6. No hazardous waste will be taken.

- Large Bulk Items set by city when charged by wholesaler
- Minimum special pickup charges to be arranged between city and collector.

REGULATIONS:

1. Regulation container (manually emptied)
 - a. Size-32 gallon maximum not to exceed 50 pounds in weight when filled and 18 pounds when empty.
 - b. Containers must have lids and handles.
 - c. Containers must be kept clean and in good condition. Plastic liners are recommended.
2. Container placement must be at curb or roadside..
3. All garbage must be drained of excess liquids and wrapped.
4. Ashes will be taken **ONLY** if placed a in plastic bag and tied. (FIRE HAZARD TO EQUIPMENT AND TRANSFER STATION.)
