# Minutes City of Irrigon Council Meeting August 20, 2024 – 6:00 PM Irrigon City Hall – 500 NE Main Ave Irrigon, OR 97844

#### Call to order/Pledge/Roil Call

Mayor Michelle Patton called the meeting to order at 6:00 PM and led in the Pledge of Allegiance.

Councilors present: Mayor Michelle Patton, Mayor Pro-Tem Benji Calvert, Councilor Daren Strong, Melvin Lamber, Marlina Avila-Serratos, and Heather Bishop.

Staff present: City Manager Aaron Palmquist, Carla McLane of McLane Consulting, and Trista Seastone City Clerk.

Audience Present: John Bass, Barbara Hulse and Ruth Bostick.

Zoom: None

#### Mayors Comments

Mayor Michelle Patton reminded everyone that the Irrigon Farmer's Market only has one more week and will close until next season. Patton stated the Fourth Street paving project is complete and the street looks amazing. The city has received numerous compliments on the improvements the city has made recently. Mayor Patton was excited to announce that the State Parks Advisory Committee has recommended approval of Irrigon's splash park concept. This means that we now need to wait for the formal award of the 1-million-dollar grant for the Irrigon Splash Park by Oregon Parks Commission on September 18, 2024. Design and bidding hopefully to take place in 2026.

1. Public Comment – Maximum 3 minutes/per person/per topic. A maximum of 30 minutes maybe be allotted for the public comment. This is the time provided for individuals wishing to address the council, at their discretion. Multiple items on the same topic need to be combined through one speaker. Please email clerk@ci.irrigon.or.us your comments or questions by 4:00 PM of the meeting date so that the mayor and council can hear your comment or question.

Barbara Hulse asked if someone could provide her with a detailed list of equipment that the construction company, utility company or city have left to be placed in front of her home. Hulse states that she has several utility boxes, signs, etc. that are in front of her home, and she does not understand why everything must be placed in front of her house. Barbara stated that she would like a 6-foot fence to put in front of her house, so she doesn't have to look at it. Hulse stated that every time she turns around there is someone else on her property or in front of it. Barbara stated there is a highway all the way to the Family Dollar for signs, poles and utility boxes to be placed, and doesn't understand why it is in front of her house.

Mayor Patton advised Barbara that she is on a main highway through the middle of town and all the utility boxes, signs and poles are placed appropriately. Staff added that there should not be any further items to be placed in front of the residence.

Ruth Bostick addressed the council and asked who owns the property next to her and when will she be getting her fence? Staff replied to Bostick that the property she is inquiring about is owned by the City of Irrigon and is the site of the future incubator building. There will be a 6- foot fence placed between the properties, however that will not happen until the RFP goes out and a bid is accepted by the council. The bid will include this fence project and will therefore be included in the total price of the project. Ruth insisted that she wants a chain link fence, and it will be less expensive for the project. Staff stated a wooden fence with metal posts will be installed. Councilor Heather Bishop asked Ruth Bostick if there was a particular reason she would like a chain link fence vs. a wood fence? Ruth stated that she feels they are less expensive to install and have little upkeep. Bishop pointed out that the cost of installation would be part of the bid process and future maintenance would fall on the city. Council members commented that for privacy, chain length fencing would not be a good option. Staff reiterated the fence will be wood.

#### 3. \*LOC 2024 Legislative Agenda Priority Votes

The City Council was provided the Legislative Agenda Priority List and a brief explanation of each topic in the city council packet for their review. Staff then took all 35 topics considered important to each councilor and chose the most common topics to create a list to be submitted to the LOC.

- Infrastructure Funding
- Behavioral Health Enhancements
- Address Energy Affordability Challenges from Rising Utility Costs
- Resilient, Futureproof of Broadband Infrastructure and Planning Investment
- 2025 Transportation Package
- Operator In Training Apprenticeships

These will be priorities for the League's 2025-2026 legislative cycle. Each city gets five total votes, however there was a tie and staff stated six would be sent in.

Councilor Heather Bishop moved to approve the priorities as discussed and noted.

Councilor Benji Calvert seconded the motion.

There was no further discussion.

Motion passed unanimously.

## 4. \*Title 1 Lexipol Law Enforcement Policies Ord 259-23 – Second Read

Ordinances come before the council twice if the document is not available at least seven (7) days prior to the first reading. This document has been previously approved by the City Council and has been reviewed by LEXIPOL, this is the second read.

Policies have been reviewed by LEXIPOL and they have confirmed the ordinance is following federal, state and law enforcement industry practices. LEXIPOL has made sure that City of Irrigon has the correct legal and appropriate policies. Staff recommended the adoption of ORD 259-23.

Councilor Melvin Lambert moved to adopt Ordinance 259-23 as presented being finalized policies as presented by Lexipol.

Councilor Benji Calvert seconded the motion.

Councilor Benji Calvert asked staff if the policy manual would ever be available online. According to City Manager Aaron Palmquist, it would not go online, however, the document is available at City Hall. Councilor Calvert asked when a policy is updated, is it removed and updated? Aaron Palmquist said yes, and former policies are kept. Calvert then asked who is notified when there are updates and changes? Per Aaron Palmquist he is the only one that is notified.

There was no further discussion.

Motion passed unanimously.

## 5. \*Resolution 24-09 House Bill 1530 Infrastructure Project Administered by Business Oregon

The State Legislation under House Bill 1530 awarded the City of Irrigon \$1, 705,000 to assist the city in infrastructure and housing for Molly I and NW Columbia project. The funds have been awarded, but part of the acceptance process requires the council to sign a resolution for disbursement of the funds. The resolution was included in the council packet.

Councilor Benji Calvert moved to adopt Resolution 24-09 as presented.

Councilor Melvin Lambert seconded the motion.

There was no discussion.

Motion passed unanimously.

## 6. \*Resolution 24-10 Supporting Special Districts

Recent negotiations regarding the ASA contract between Morrow County Health District (MCHD) and Morrow County Board of Commissioners was discussed with cities, all special districts within Morrow County should be shown support by the cities they serve. Adopting this resolution that is written in support for all special districts, acknowledges each special district and what services and opportunities they provide the community.

Councilor Benji Calvert moved to adopt Resolution 24-10 as presented.

Councilor Daren Strong seconded the motion.

There was no discussion.

Motion passed unanimously.

## 7. \*Resolution 24-04 Amended UEC Food Pod Funding Loan Opportunity

The City Council previously accepted loan funding up to \$390,000.00. Resolution 24-04 Amended is to provide clarification and updates to the loan process. The amended resolution outlines the details of the full loan amount from two different sources. The amounts meet the previously approved limit with an estimated loan amount with the approved limits and projects.

#### Noteworthy items are:

- No loan draws will take place until the city council accepts and awards the perspective contractor.
   This is estimated to happen in December or January 2025.
- Each loan amount will be drawn separately as required.
- It is estimated that a supplemental budget will be needed this fiscal year but will take place when a contract is awarded for the project and of how many resources will need to be borrowed this fiscal year.
- There will be no early pay off penalty. Staff will be closely monitoring as CREZ funds are received to ensure timely paybacks.

Councilor Daren Strong moved to accept Resolution 24-04 Amended as presented.

Councilor Heather Bishop seconded the motion.

No discussion.

Motion passed unanimously.

#### 8. \*Purchase of a Vac Truck

The city uses multiple pieces of equipment to complete a job that one piece of equipment has the capabilities of doing. Public Works may have to use the backhoe, small jet trailer, and the pumper truck to complete one job. Staff have researched the cost of new equipment and found costs in the range of \$600,000 to \$1,000,000, however, staff recently had a contractor doing local work and were informed that their own Vac Truck would soon be on the market for purchase. The contractor stated a 2008 Vac Truck had maintenance every 200 hours, 13,719 hours on it, and 239,200 miles. The contractor stated the Vac Truck would have a price tag of \$40,000. Having a Vac Truck would greatly reduce the potential of damage and breaks to existing underground infrastructure (water and sewer, phone lines, etc.) A Vac Truck jets water to cut through dirt and simultaneously vacuums it up within a small area or hole.

#### Areas of consideration are:

- Safety
- Time
- Cost savings (maintenance, insurance)
- Being without equipment during repairs

Equipment currently owned by the city that is recommended for disposal is the jet trailer and large pumper truck. There are other cities that have expressed interest in purchasing these items, however, no price has been discussed at this time as this action would be brought back to the council at a future meeting to fulfill notice requirements.

Resources are set aside for the purchase of a 1- ton vehicle in the amount of \$90,000 and this purchase of \$40,000 would be half that amount. Staff stated that the city would continue setting aside funds to replenish for the 1-ton purchase later.

Councilor Heather Bishop moved to authorize the purchase of a Vac Truck as presented and use funds as specified from CIP saved resources in the of \$40,000.

Councilor Benji Calvert seconded the motion.

Councilor Calvert asked staff if there was any idea on how much the city would have saved prior to purchasing?

Staff stated that there was no figure at the present time to share with the council.

There was no further discussion.

Motion passed unanimously.

## 9. Employment Land, Strategies Plan - Information/Discussion

Carla McLane of Carla McLane Consulting, LLC was present at the city council meeting to discuss a possible development project on some property just east of Irrigon. A memorandum written by McLane was included in the city council packet for review. The memo outlined land that has the potential of being used for bringing in light industrial businesses to Irrigon. Irrigon has done well working with builders to increase the housing availability in Irrigon, and the next step to enhance the city would be to bring in some new businesses and have larger land available to do so.

After listening to the presentation by Carla, Mayor Patton addressed staff and Carl McLane and asked for a more detailed plan to be brought to the October 15, 2024 council meeting. The council is interested in a pros and cons list, including examples of types of industrial businesses, and a more comprehensive mapping of the potential land available and the surrounding area.

Carla McLane stated that she would be able to do another presentation with the details requested and will bring it to the October 15, 2024, meeting.

## City Manager Report 9-17-2024

The months of August and September are flying by fast, so it seems. School is back in session and daylight hours are getting shorter. Please continue to use caution as youth, families, and walkers are out as we move into the fall season. It also means that there are many projects and events still yet to take place before we end out the 2024 year. Change is always around and is a process, not an event.

Another year of the Irrigon Farmers Market is complete. Each year the participation and desire grow. The market coordinator and myself are already planning for next year.

Overall, we have completed several major projects, which continues to bring improvements to Irrigon. Council, staff, contractors and our City Engineers - JUB have played an immense role in the achievements. While there are some, and very few, who may be disgruntle or complain, the majority say thank you to the city and team for embarking on the continued success.

As noted in last month's meeting Carla and I are working on areas to bring back to the City Council for clearer direction on economic development strategies.

Our "Motto" contest is underway. The fliers have been sent to the local schools and we have notices here for the general public. If anyone on the council has any suggestions for a motto option to be included, please apply.

#### Court/Law Enforcement

Last month I noted that two properties had call usage that was created an out of balance use of systems and services. The law enforcement report still shows a large number of calls from these properties and individuals. However, notification has been made that such action is a code violation and since the letters were sent calls have drastically taken place and are being worked to refrain from chronic calls and complaints. If an item is truly an emergency and verifiable, such as EMS, etc., those calls are taken and responded to accordingly and timely. We appreciate the work law enforcement is doing. Their hours are higher than historical averages but this is taking place as Morrow County has new deputies hired and are in training.

Multiple code violation warning notices continue to be sent out. Some non-compliant properties have pushed all options and citations have had to be presented. We thank all of those who have complied with the notifications of code violations. There is a big shout out to those individuals and properties that continue every day in keeping and maintaining their properties in accordance with the City Code, providing a positive presentation of our community and those who interface across the area. Thank you, council and staff, for setting the example in leading the way in beautify and keeping our respective areas presentable and in compliance with the municipal code.

If anyone is interested in improving and beautifying their respective properties, please contact city hall. The grant funds that are available are for front property (visible) areas, up to \$2,000.00, can be applied for every three (3) years, and is for every developed property (owner may have multiple property locations) for those properties in the 97844-zip code area.

The Irrigon Municipal Court continues to see compliance which takes place through accountability and responsibility. As individuals or properties are cited into our court and there is court action there may be charges that are not always immediately paid, resulting in an increase in accounts receivables. Our judge and court staff are exploring avenues to assist paying individuals while also collecting those charges during hard or challenging situations.

### Public Works (PW)

The Safe Routes to Schools (SRTS) sidewalk by the school is complete and the acceptance documents are in tonight's packet. This project completion is exciting to finally have completion to a long process (six years) to reach the end result we have today.

The bid has been publicized for the new packaged lift station on NW Columbia Lane. This item and the soon to be

construction bid are part of the SB1530 grant that was awarded to Irrigon for increased housing opportunities. Staff will be reviewing the design plans over the next four weeks to ensure all items are clearly noted for bidding. As part of this project, we need easements to install city utilities along the north side of NW Columbia Lane while eliminating underground utility conflicts. A council item is in this month's packet for such action.

We are excited about a future splash park for Irrigon. Notification is to be officially made later this month by the Oregon State Parks Commission in which we anticipate grant documents should be ready for council action in October, but no later than November.

The Irrigon Food Pod project is being finalized and staff will review over the next couple of weeks to ensure a timely bidding process for this fall. The spring of 2025 is the anticipated construction start time.

Now that summertime is over, we should see property water bills go down to the winter season usage. If individuals have a challenge with their bills the city recommends that they consider "Budget Billing" to balance out their bills on a more consistence basis. The other alternative would be to evaluate how and when water is used during the summer months. While there may be some properties that have leaks, or concerns we will review the historical usage and check the system for leaks. As of now they meters are calibrated correctly and no property has system issues. If there are leaks noticed or found by the property staff will work with the properties to see that any leaks (on the owner side it is property responsibility) are timely repaired by the property owner, keeping rising water usage at bay.

We are still awaiting the results of the annual ODOT SCA Grant, (Small City Allotment). According to historical processes we should be successful this year as part of the rotation and award schedule. If we are successful, we do not anticipate any grant documents for action until the November or December council meeting. The planning goal is to make continually applications to install sidewalks from the City Hall parking lot down to AC Houghton.

SE Greenwood and SE Fourth Street have new paving and has made the neighborhoods look better, with the residents thankful for the work. SE Fourth has a few water valves and manhole areas that need concrete base work installed around the locations for protection. On SE Division Street there also was some concrete manhole work and paving was to be accomplished and was pushed out by the asphalt plants as Amazon has a very large job they are trying to accomplish before the plants close for the season. We have been advised that repair and paving to the utility crossing areas on SE Division is to take place within the next week. Thank you for your patience as the contractor(s) work through coordination with the asphalt batch plants.

There are a couple areas where striping arrows (NE Third and US 730) and a No Parking zone (by the bus shelter) are scheduled to take place when the weather as a few consecutive dry and warmer days. This should then conclude our striping for the season.


#### Financial/Administration

The attached Intergovernmental Agreement (IGA) is with ODOT for ADA Curb services of the US 730 Sidewalk Project. This agreement provides ODOT's and the City of Irrigon's roles and responsibilities with and through the design and construction of the project.

This IGA is a result of a multi-year ODOT lawsuit that requires ODOT to repair and/or install correct legal ADA ramps at known intersections across the state. The ADA curb ramps will be on the north side of US 730 and are projected to be install over the next couple of years, or sooner. City staff has worked diligently with ODOT In ensuring language does not put the city at risk of liability by acceptance of something directed by a state agency. All language has been cleaned up and made acceptable.

The language has been reviewed by the Oregon DOJ (Department of Justice) to be true and correct.

Staff recommends that City Council authorize the Mayor and City Manager to sign the IGA as presented.

# INTERGOVERNMENTAL AGREEMENT Americans with Disabilities Act Curb Ramp Project Agreement

Umatilla/Morrow County Curb Ramps Phase 2B, US 730 City of Irrigon

**THIS AGREEMENT** is made and entered into by and between the STATE OF OREGON, acting by and through its Department of Transportation, hereinafter referred to as "ODOT" and "State;" and the CITY OF IRRIGON, acting by and through its elected officials, hereinafter referred to as "Agency," both herein referred to individually as "Party" and collectively as "Parties."

#### **RECITALS**

- 1. US 730, Columbia River Highway, is a part of the state highway system under the jurisdiction and control of the Oregon Transportation Commission (OTC). First Street, NE Third Street, NE Division Street, NE Eighth Street, NE Tenth Street, NE Twelfth Street, NE Thirteenth Street and NE Fourteenth Street are a part of the city street system under the jurisdiction and control of Agency.
- 2. By the authority granted in Oregon Revised Statutes (ORS) 190.110, 366.572, and 366.576, State may enter into cooperative agreements with counties, cities, and units of local governments for the performance of work on certain types of improvement projects with the allocation of costs on terms and conditions mutually agreeable to the contracting parties.
- 3. State, by ORS <u>366.220</u>, is vested with complete jurisdiction and control over the roadways of other jurisdictions taken for state highway purposes. The Parties initially agree that the jurisdiction extends from ROW to ROW. Responsibility for and jurisdiction over all other portions of a city street remains with Agency. The Parties further understand and agree to amend this Agreement if the jurisdiction stated in this recital is altered or determined to be incorrect.
- 4. Traffic control devices that are part of the Project will conform to current State standards and specifications, including but not limited to the Manual on Uniform Traffic Control Devices (MUTCD). The Oregon Administrative Rules (OAR) Chapter 734, Division 55, governs the location, installation, and maintenance of signs, miscellaneous facilities, and miscellaneous operations on the state highway right of way.
- 5. In order for State to ensure that curb ramps along the state highway system are in compliance with the current standards of Section 504 of the Rehabilitation Act of 1973 and the Americans with Disabilities Act of 1990 as amended (together "ADA"), State intends to enter into agreements with local public agencies throughout the state for construction projects to ensure curb ramps identified in the Statewide Transportation

Improvement Program (STIP) are ADA compliant. This Agreement identifies the Parties' respective responsibilities.

- 6. The following curb ramps along the south side of US 730 will be constructed or rehabilitated under the City of Irrigon's sidewalk infill project via a separate HB2017 agreement (32610): NE Third Street, SE/SW corners at SE Fourth Street, SE/SW/NW corners of Division Street, SE/SW corners of SE Seventh Street, SE/SW corner of Eighth Street, SE/SW corner of Tenth Street, SE/SW/NW areas of Eleventh Street, SE/SW corners of SE Thirteenth street, SE/SW/NE corners of Fourteenth Street.
- 7. Maintenance responsibilities for any existing rectangular rapid flashing beacon (RRFB) to be replaced or location adjusted according to the project plans (1st Street) remain as assigned when originally constructed. (Agreement 28740)

**NOW THEREFORE**, the premises being in general as stated in the foregoing Recitals, it is agreed by and between the Parties hereto as follows:

### TERMS OF AGREEMENT

- 1. Under such authority, State and Agency agree that State shall design and construct ADA-compliant curb ramp improvements at various locations along US 730 from Mile Point 175.20 to 176.10, hereinafter referred to as "Project." The Project includes construction or rehabilitation of curb ramps to meet current ADA standards, and replacement of the RRFB at First Street and US 730. The location of the Project is approximately as shown on the sketch map attached hereto, marked Exhibit A, and by this reference made a part hereof.
- 2. The following curb ramps along US 730 will be constructed or rehabilitated under this Project:
  - NE/SE corners of NE/SE First Street
  - NW corner of NE Third Street
  - NW/NE corners of NE Division Street
  - NW/NE corners of NE Eighth Street
  - NW/NE corners of NE Tenth Street
  - NW/NE corners of NE Twelfth Street
  - NW/NE corner of NE Thirteenth Street
  - NW corner of NE Fourteenth Street

- 3. The Project will be financed at an estimated cost of 665,000 in federal and state funds. The estimate for the total Project cost is subject to change. State shall be responsible for any Project costs beyond the estimate.
- 4. This Agreement shall become effective on the date all required signatures are obtained (Effective Date) and shall remain in effect for the purpose of ongoing maintenance responsibilities for the useful life of the facilities constructed as part of the Project. The useful life is defined as twenty (20) calendar years. The Project shall be completed within 2 calendar years following the Effective Date of this Agreement.

## **AGENCY OBLIGATIONS**

- 1. Agency shall review State's Project plans prior to construction of the Project.
- 2. Agency grants State the right to enter onto Agency's right of way for the performance of duties as set forth in this Agreement.
- 3. Agency agrees to State acquiring all right of way needed for construction of the Project. Upon completion of the Project, and in consideration of the improvements constructed as part of the Project, Agency agrees to accept any property transferred by the State that is no longer needed for the construction of the Project. If said property is no longer needed by Agency for public road purposes, it shall revert to ODOT.
- 4. Following Project completion, Agency shall be responsible for and agrees to maintain the Project improvements within Agency right of way with its own forces and at its own expense, including, but not limited to, all surface, sub-surface features such as storm water systems, curbs, gutters, sidewalks, fences, sanitary sewer, water lines, and all other features that are within Agency right of way. Any maintenance responsibilities that are not part of this Agreement that are currently in effect shall remain unchanged.
- 5. Agency shall not enter into any subcontracts for any of the work scheduled under this Agreement without obtaining prior written approval from State.
- 6. Agency delegates, and the State accepts, the Agency's authority pursuant to ORS 758.010, ORS 758.025 and all relevant common law, statutes, ordinances, permits, and agreement terms, to cause to be relocated or reconstructed, all privately and publicly owned utility conduits, lines, poles, mains, pipes, and all other such facilities of every kind and nature where such relocation or reconstruction is made necessary by the plans of the Project in order to conform the utilities and other facilities with the plans and the ultimate requirements for the portion of the project upon lands within the Agency's jurisdiction.
- 7. Agency shall comply with all federal, state, and local laws, regulations, executive orders and ordinances applicable to the work under this Agreement, including, without limitation, the provisions of ORS 279C.505, 279C.515, 279C.520, 279C.530 and 279B.270 incorporated herein by reference and made a part hereof. Without limiting the generality of the foregoing, Agency expressly agrees to comply with (i) Title VI of Civil Rights Act of 1964; (ii) Title V and Section 504 of the Rehabilitation Act of 1973;

- (iii) the Americans with Disabilities Act of 1990 and ORS 659A.142; (iv) all regulations and administrative rules established pursuant to the foregoing laws; and (v) all other applicable requirements of federal and state civil rights and rehabilitation statutes, rules and regulations.
- 9. Agency by execution of this Agreement, gives its consent as required by ORS 373.030(2) and ORS 105.760 to any and all changes of grade within Agency limits, and gives its consent as required by ORS 373.050(1) to any and all closure of streets intersecting the highway, if any, in connection with or arising out of the Project covered by this Agreement.
- 10. Agency shall be exclusively responsible for all costs and expenses related to its employment of individuals to perform the work under this Agreement including, but not limited to, retirement contributions, workers compensation, unemployment taxes, and state and federal income tax withholdings.
- 11. All employers, including Agency, that employ subject workers who work under this Agreement in the State of Oregon shall comply with ORS <u>656.017</u> and provide the required Workers' Compensation coverage unless such employers are exempt under ORS <u>656.126</u>. Employers Liability insurance with coverage limits of not less than \$500,000 must be included. Agency shall ensure that each of its contractors complies with these requirements.
- 12. Agency acknowledges and agrees that State, the Oregon Secretary of State's Office, the federal government, and their duly authorized representatives shall have access to the books, documents, papers, and records of Agency which are directly pertinent to the specific Agreement for the purpose of making audit, examination, excerpts, and transcripts for a period of six (6) years after termination or expiration of this Agreement. Copies of applicable records shall be made available upon request. Payment for costs of copies is reimbursable by State.
- 13. Agency certifies and represents that the individual(s) signing this Agreement has been authorized to enter into and execute this Agreement on behalf of Agency, under the direction or approval of its governing body, commission, board, officers, members, or representatives, and to legally bind Agency.
- 14. Agency's Project Manager for this Project is Aaron Palmquist, City Manager, 500 NE Main Avenue, Irrigon, Oregon 97844; telephone: (541) 922-3047; email: <u>Aaron.Palmquist@ci.irrigon.or.us</u>, or assigned designee upon individual's absence. Agency shall notify the other Party in writing of any contact information changes during the term of this Agreement.

## STATE OBLIGATIONS

 State shall conduct the necessary field surveys, environmental studies, traffic investigations, preliminary engineering, and design work required to produce and provide final plans, specifications, and cost estimates for the Project; identify and obtain all required permits; perform all construction engineering, including all required materials testing and quality documentation; prepare all bid and contract documents; advertise for construction bid proposals; award all contracts; pay all contractor costs; and provide technical inspection, project management services, and other necessary functions for sole administration of the construction contract entered into for this Project.

- 2. State shall provide Project plans to Agency for review prior to construction of the Project.
- 3. State shall allow Agency access to State's right of way to perform maintenance obligations on constructed Project improvements specified in Agency Obligations, Paragraph 4.
- 4. State shall conduct all right of way activities in accordance with the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended, ORS Chapter 35, Federal-Aid Policy Guide, Code of Federal Regulations (CFR), including but not limited to Title 23 CFR Part 710 and Title 49 CFR Part 24, and the ODOT Right of Way Manual.
- 5. Upon Project completion, State shall transfer to Agency any ownership interests State may have obtained for the Project along Agency's facilities. The method of conveyance will be determined by the Parties at the time of transfer and will be coordinated by State's Region Right of Way Manager. If said property is no longer needed by Agency for public road purposes, it shall revert to ODOT.
- 6. State, or its consultant shall cause to be relocated or reconstructed, all privately or publicly owned utility conduits, lines, poles, mains, pipes, and all other such facilities of every kind and nature where such relocation or reconstruction is made necessary by the plans of the Project in order to conform the utilities and other facilities with the plans and the ultimate requirements for the portions of the Project which may interfere with the ADA Improvements.
- 7. Following Project completion, State shall be responsible for and agrees to maintain the Project improvements within State ROW on the north side of Hwy 730 between NE Fourth Street and NE Fourteenth Street.
- 8. State certifies, at the time this Agreement is executed, that sufficient funds are available and authorized for expenditure to finance costs of this Agreement within State's current appropriation or limitation of the current biennial budget.
- 9. State's Project Manager for this Project is Erin Winterton, Transportation Project Manager, 3012 Island Avenue, La Grande, Oregon 97850; telephone: (541-252-2226); email: <a href="mailto:Erin.Winterton@odot.oregon.gov">Erin.Winterton@odot.oregon.gov</a>, or assigned designee upon individual's absence. State shall notify the other Party in writing of any contact information changes during the term of this Agreement.

#### **GENERAL PROVISIONS**

## 1. Americans with Disabilities Act Compliance:

- a. When the Project scope includes work on sidewalks, curb ramps, or pedestrianactivated signals, or triggers an obligation to address curb ramps or pedestrian signals, the Parties shall:
  - Utilize ODOT standards to assess and ensure Project compliance with Section 504 of the Rehabilitation Act of 1973 and the Americans with Disabilities Act of 1990 as amended (together, "ADA"), including ensuring that all sidewalks, curb ramps, and pedestrian-activated signals meet current ODOT Highway Design Manual standards;
  - ii. Follow ODOT's processes for design, construction, or alteration of sidewalks, curb ramps, and pedestrian-activated signals, including using the ODOT Highway Design Manual, ODOT Design Exception process, ODOT Standard Drawings, ODOT Construction Specifications, providing a temporary pedestrian accessible route plan and current ODOT Curb Ramp Inspection Form;
  - iii. At Project completion, send a completed ODOT Curb Ramp Inspection Form 734-5020 to the address on the form as well as to State's Project Manager for each curb ramp constructed or altered as part of the Project. The completed form is the documentation required to show that each curb ramp meets ODOT standards and is ADA compliant. ODOT's fillable Curb Ramp Inspection Form and instructions are available at the following address:
    - https://www.oregon.gov/ODOT/Engineering/Pages/Accessibility.aspx
- b. Agency shall ensure that any portions of the Project under Agency's maintenance jurisdiction are maintained in compliance with the ADA throughout the useful life of the Project. This includes, but is not limited to, Agency ensuring that:
  - i. Pedestrian access is maintained as required by the ADA,
  - ii. Any complaints received by Agency identifying sidewalk, curb ramp, or pedestrian-activated signal safety or access issues are promptly evaluated and addressed,
  - iii. Agency, or abutting property owner, pursuant to local code provisions, performs any repair or removal of obstructions needed to maintain the facility in compliance with the ADA requirements that were in effect at the time the facility was constructed or altered,
  - iv. Any future alteration work on the Project or Project features during the useful life of the Project complies with the ADA requirements in effect at the time the future alteration work is performed, and

- v. Applicable permitting and regulatory actions are consistent with ADA requirements.
- c. Maintenance obligations in this section shall survive termination of this Agreement.
- 2. Utility relocation or reconstruction may or may not be an eligible Project expense according to the following standard:
  - a. The expense is an eligible expense if the owner of the utility facility possesses a property right for its location on the public right of way.
  - b. The expense is not an eligible expense if the owner of the utility facility does not possess a property right for its location, but the facility exists on the public right of way solely under the permission of Agency or other road authority, whether that permission is expressed or implied, and whether written or oral.
- 3. This Agreement may be terminated by mutual written consent of both Parties.
- 4. State may terminate this Agreement effective upon delivery of written notice to Agency, or at such later date as may be established by State, under any of the following conditions:
  - a. If Agency fails to provide services called for by this Agreement within the time specified herein or any extension thereof.
  - b. If Agency fails to perform any of the other provisions of this Agreement, or so fails to pursue the work as to endanger the performance of this Agreement in accordance with its terms, and after receipt of written notice from State fails to correct such failures within ten (10) days or such longer period as State may authorize.
  - c. If State fails to receive funding, appropriations, limitations, or other expenditure authority sufficient to allow State, in the exercise of its reasonable administrative discretion, to continue to make payments for the performance of this Agreement.
  - d. If federal or state laws, regulations or guidelines are modified or interpreted in such a way that either the work under this Agreement is prohibited, or State is prohibited from paying for such work from the planned funding source.
- 5. Any termination of this Agreement shall not prejudice any rights or obligations accrued to the Parties prior to termination.
- 6. If any third party makes any claim or brings any action, suit or proceeding alleging a tort as now or hereafter defined in ORS 30.260 ("Third Party Claim") against State or Agency with respect to which the other Party may have liability, the notified Party must promptly notify the other Party in writing of the Third Party Claim and deliver to the

other Party a copy of the claim, process, and all legal pleadings with respect to the Third Party Claim. Each Party is entitled to participate in the defense of a Third-Party Claim, and to defend a Third-Party Claim with counsel of its own choosing. Receipt by a Party of the notice and copies required in this paragraph and meaningful opportunity for the Party to participate in the investigation, defense, and settlement of the Third-Party Claim with counsel of its own choosing are conditions precedent to that Party's liability with respect to the Third-Party Claim.

- 7. With respect to a Third Party Claim for which State is jointly liable with Agency (or would be if joined in the Third Party Claim), State shall contribute to the amount of expenses (including attorneys' fees), judgments, fines, and amounts paid in settlement actually and reasonably incurred and paid or payable by Agency in such proportion as is appropriate to reflect the relative fault of State on the one hand and of Agency on the other hand in connection with the events which resulted in such expenses, judgments, fines, or settlement amounts, as well as any other relevant equitable considerations. The relative fault of State on the one hand and of Agency on the other hand shall be determined by reference to, among other things, the Parties' relative intent, knowledge, access to information, and opportunity to correct or prevent the circumstances resulting in such expenses, judgments, fines, or settlement amounts. State's contribution amount in any instance is capped to the same extent it would have been capped under Oregon law, including the Oregon Tort Claims Act, ORS 30.260 to 30.300, if State had sole liability in the proceeding.
- 8. With respect to a Third Party Claim for which Agency is jointly liable with State (or would be if joined in the Third Party Claim), Agency shall contribute to the amount of expenses (including attorneys' fees), judgments, fines, and amounts paid in settlement actually and reasonably incurred and paid or payable by State in such proportion as is appropriate to reflect the relative fault of Agency on the one hand and of State on the other hand in connection with the events which resulted in such expenses, judgments, fines, or settlement amounts, as well as any other relevant equitable considerations. The relative fault of Agency on the one hand and of State on the other hand shall be determined by reference to, among other things, the Parties' relative intent, knowledge, access to information, and opportunity to correct or prevent the circumstances resulting in such expenses, judgments, fines, or settlement amounts. Agency's contribution amount in any instance is capped to the same extent it would have been capped under Oregon law, including the Oregon Tort Claims Act, ORS 30.260 to 30.300, if it had sole liability in the proceeding.
- If Agency fails to maintain facilities in accordance with the terms of this Agreement, State, at its option, may maintain the facility and bill Agency, seek an injunction to enforce the duties and obligations of this Agreement or take any other action allowed by law.
- 10. The Parties shall attempt in good faith to resolve any dispute arising out of this Agreement. In addition, the Parties may agree to utilize a jointly selected mediator or arbitrator (for non-binding arbitration) to resolve the dispute short of litigation.

- 11. Agency and State are the only parties to this Agreement and are the only parties entitled to enforce its terms. Nothing in this Agreement gives, is intended to give, or shall be construed to give or provide any benefit or right, whether directly, indirectly or otherwise, to third persons unless such third persons are individually identified by name herein and expressly described as intended beneficiaries of the terms of this Agreement. This provision survives expiration or termination of the Agreement.
- 12. The Parties agree that if any term or provision of this Agreement is declared by a court of competent jurisdiction to be invalid, unenforceable, illegal or in conflict with any law, the validity of the remaining terms and provisions shall not be affected, and the rights and obligations of the Parties shall be construed and enforced as if the Agreement did not contain the particular term or provision held to be invalid. This provision survives expiration or termination of the Agreement.
- 13. This Agreement may be executed in several counterparts (facsimile or otherwise) all of which when taken together shall constitute one agreement binding on all Parties, notwithstanding that all Parties are not signatories to the same counterpart. Each copy of this Agreement so executed shall constitute an original.
- 14. This Agreement and attached Exhibits constitute the entire agreement between the Parties on the subject matter hereof. There are no understandings, agreements, or representations, oral or written, not specified herein regarding this Agreement. No waiver, consent, modification, or change of terms of this Agreement shall bind either Party unless in writing and signed by both Parties and all necessary approvals have been obtained. Such waiver, consent, modification, or change, if made, shall be effective only in the specific instance and for the specific purpose given. The failure of State to enforce any provision of this Agreement shall not constitute a waiver by State of that or any other provision.
- 15. Electronic Signatures. The Parties agree that signatures showing on PDF documents, including but not limited to PDF copies of the Agreement and amendments, submitted or exchanged via email are "Electronic Signatures" under ORS Chapter 84 and bind the signing Party and are intended to be and can be relied upon by the Parties. State reserves the right at any time to require the submission of the hard copy originals of any documents.





RE: Easements for ODOT US 730 ADA Curb Project Item #5

Enclosed are easement agreements with ODOT for ROW (permanent and temporary) services of the US 730 ADA Curb Ramp Project. These easements provide ODOT's the ability to temporarily work within the noted areas and provide for permanent easement for ODOT's requirement to maintain the installed ADA curb ramps. Temporary easements are for improvements for known and potential areas where a worker may step or need to step on city property. Permanent easements will be drafted accordingly following the final design and construction of the ADA ramps along the north side of US 730. Not all curb ramps, as noted, do not require the city to authorize any easements as they will be fully in the ODOT ROW.


RE: Utility Easements for Burris and Stokes Senior Landing Senior Center Properties #7

The attached location description portrays utility easement locations for city water and sewer infrastructure to traverses across the Burris (5 feet) and Stokes Landing Senior Center (15 feet). The proposed easements are to ensure that the SB1530 Infrastructure grant project can successfully be installed and that such instruments need to be formally documented and recorded for the property owner(s) of such easements.


The city attorney is finalizing the documents to ensure correct and legal descriptions are noted. The Burris' have formally agreed to the easement and a formal vote should be forthcoming from Stokes Landing Seniors while there has been general consensus to proceed. While this infrastructure is designed for housing improvements it will also benefit future developments and builds consistency into the city's infrastructure system.
